


PRO BONO PROGRAMS

ATTORNEY AD LITEM TEAM

In 2022, at the request of Chancellor Kathaleen McCormick, the firm started an attorney *ad litem* pro bono team to serve as attorneys *ad litem* in adult guardianship hearings in the Delaware Court of Chancery through **Delaware** Volunteer Legal Services (DVLS). Rob Burns and Chad Shandler are co-chairs of this 15-member team. Rob Burns, Susan Hannigan Cohen, and Nicole Henry, among others, have represented clients in these matters, and many other RLF attorneys have completed the required training.

FEDERAL CIVIL PANEL TEAM

The firm participates in the Federal Civil Panel under the auspices of the U.S. District Court for the District of Delaware. Through this program, the firm receives referrals from the Federal District Court of cases filed by indigent plaintiffs, typically involving alleged civil rights violations. This program is intended to give attorneys the opportunity to first-chair active litigation matters in the Delaware District Court. The Federal Civil Panel Team is led by Kelly Farnan.

NON-PROFIT TEAM

This team's goal is assisting non-profit organizations with various legal projects, including drafting incorporation documents, answering legal questions, and serving on or counseling non-profit boards. It is a popular team among the firm's attorneys, with 41 members. The Non-Profit Team is led by Elisa Erlenbach Maas and John Mark Zeberkiewicz.

The Non-Profit Team hosted a variety of presentations directed to attorneys who serve or are interested in serving on a non-profit board of directors. In November 2023, directors Mark Collins, Anne Foster, Josh Novak, and Sara Wagner presented the CLE, Non-Profit Boards: Understanding the Role and the Opportunity.

In February 2024, the Non-Profit Team hosted the CLE presentation, Reviewing Financial Statements as a Non-Profit Board Member, featuring director Mark Gentile and Alyssa Pietrobono, CPA, MBA, MSA.

In November 2024, the Non-Profit Team hosted the CLE presentation, Nonprofit Governance from a *Lifecycle Perspective*, featuring Sheila Bravo, PhD, President and **CEO of the Delaware Alliance for** Nonprofit Advancement (DANA).



OFFICE OF THE CHILD ADVOCATE TEAM

The Office of the Child Advocate ("OCA") Team is comprised of 33 attorneys, led by Jennifer Jauffret. Over the course of the year, 13 RLF attorneys represented 14 children in abuse and neglect proceedings, providing an important service to the court and the children as well as valuable litigation and counseling experiences for our lawyers. Our attorneys dedicated over 235 hours as child attorneys in FY 2024.

Since the inception of this program over 20 years ago, our attorneys have dedicated over 14,750 hours to the representation of 295 children in these Family Court proceedings. In 2024, the Office of the Child Advocate honored Gregory Ladner with a 20-Year Service Award and Nicole Henry with a 5-Year Service Award.

In February 2024, the OCA Team hosted Kelly Ensslin, Esq., Chief of Legal Services for the Office of the Child Advocate, for the training CLE, Nuts & Bolts of Representing Children in DSCYF.

Congratulations to the following OCA Team members who were named to the Office of the Child Advocate Pro Bono Honor Roll in 2024: Brock Czeschin and **Gregory Ladner** for 20+ years of service; Travis Hunter, Jennifer Jauffret, Cory Kandestin, Claire Love, and Amanda Steele for 10-20 years of service; Nicole Henry for 5-10 years of service; and Bobby Kissel, Kinsey Lenehan, Rae Ra, Yuan Tao, and Sandy Xu for less than 5 years of service. Thanks to these attorneys, as well as Mari Boyle and Edmond Kim, among others, who served as child attorneys in 2023 and 2024.

WILLS TEAM

This team of 35 attorneys is headed by Monica Ayres and offers services, through DVLS, to indigent seniors with estate planning and related needs. In addition to the preparation of wills, the team offers various other estate-planning options, such as the creation of health-care directives, durable powers of attorney, HIPAA authorizations, and planning documents for the disposition of last remains. This pro bono offering affords valuable one-on-one counseling opportunities for our lawyers.

In October 2023, Emanuel Perris and Frank Sun, among others, participated in a Wills for Seniors event co-hosted by DVLS and the DSBA at the Elsmere Fire Hall in honor of National Pro Bono Week. In January 2024, Andrea Filbeck volunteered at a Wills for Seniors event co-hosted by DVLS and the DSBA at the Police Athletic League in honor of Dr. Martin Luther King, Jr. Day.

In October 2024, Emanuel Perris participated in a Wills for Seniors event co-hosted by DVLS and the DSBA at the Delaware Law School in honor of National Pro Bono Week.

Maddie Jolles was the lead attorney providing pro bono estate planning services to a Delaware senior, and after consultation and discussion, a will, durable personal power of attorney, and advance health-care directive were drafted and executed. Emily Malafronti and Andrew Roedersheimer, among others, also provided pro bono support, along with Monica Ayres, who served as the supervising director on the matter.

PROTECTION FROM ABUSE TEAM

The Protection from Abuse ("PFA") Team consists of 18 attorneys who assist DVLS with obtaining protection from abuse orders for victims of domestic violence.

In November 2023, the PFA Team hosted Jacquelyn Chacona, Esq., **Director of Pro Bono Projects**, and Thomas McDonough, Esq., Director of Pro Bono Recruitment, for a CLE training presentation on handling PFA cases.

In March 2024, the PFA Team hosted **Family Court Commissioners** Danielle Blount, Esq. and Para Wolcott, Esq. for the CLE presentation, Preparing for a Protection from Abuse Hearing: Perspectives from the Bench.

In April and June of 2024, Vicky Liu and **Sandy Xu** volunteered to handle two PFA matters and a custody matter for Mandarin-speaking victims, with one of the PFA cases being resolved with a four-year consent order. DVLS expressed their deep appreciation to the firm for providing Mandarin-speaking pro bono attorneys to assist in these critical matters, noting they "were grateful for the extraordinary compassion, skill and time that the attorneys provided."

In May, Spencer Crawford negotiated a consent order on behalf of his client, which included a protection from abuse order, temporary sole custody of the children, supervised visitations with the children, and reimbursement for medical expenses stemming from injuries sustained by his client.

CO-COUNSEL PROJECT

The Co-Counsel Project arose at the request of former Chief Justice **Strine** and the state's **former public** defender, Brendan O'Neill. Private law firms were asked to provide pro bono attorneys to partner with the Public Defender's Office on serious felony cases. Our attorneys serve as second chair and are expected to research, prepare, and argue motions. The firm has eight attorneys on this team.

UNACCOMPANIED MINORS

At the request of **former Chief Justice Strine**, RLF participated with other firms in training attorneys to represent unaccompanied minors coming to Delaware. Marcos Ramos and Marisa Terranova Fissel lead this team, supervising associates as they receive requests for representation in Family Court guardianship and immigration cases.

Central Baptist Community **Development** Corporation

One of the firm's largest pro bono projects has been its ongoing work on behalf of Central Baptist Community Development Corporation ("CBCDC"). Under the leadership of directors Mark Kurtz, Tony Roustopoulos, and Sara Wagner, the firm dedicated over 540 hours in the past year representing CBCDC in connection with its Eastside Rising initiative, an effort to revitalize Wilmington's Eastside community through housing improvement, workforce development, economic empowerment, and the eradication of "food deserts." Our efforts include advising on agreements, contracts, leases, licensing, acquisitions, financing, a variety of transactions, and other matters of Delaware law. This initiative has improved both the infrastructure and the quality of life in a significant section of our community. During the past year, Avery Benesch, Chandler Elliott-Fehle, R. The firm continued its support of the Delaware Bar Foundation's mission to improve the administration of


